

II - CONSIDERAÇÕES INICIAIS

A Autora (Yeda Romualda Ferreira Cerqueira Leite) em sua petição de fls. 2/14 vem informar que em 10/11/89, firmou com o Réu, contrato de compra e venda, mútuo com obrigações e quitação parcial com a 1ª Ré, cujo financiamento é da Caixa Econômica Federal - 2ª Ré, através do SFH com recursos do FGTS, com oferta de prestações mensais com reajuste pelo PES/CP, conforme quadro resumo apresentado. Frisa, que além das prestações já estarem com juros pré-fixadas, a correção das mesmas vem sofrendo incorporação da TR, além de juros capitalizados sobre o valor do financiamento, tornando o empréstimo numa dívida impagável, sem falar no descumprimento do PES. A Ré já embutiu, maliciosamente os juros na dívida inicial, ou seja, pré-fixou os juros, onde se estabelece a tabela price, como sistema de amortização adotado no contrato, que nada mais é cálculo de juros sobre valores monetários, em função do tempo e da amortização. Passou em seguida a comentar sobre o contrato, atualização do saldo devedor, Inadimplência da TR, Código de Defesa do Consumidor e cobrança ilegal do seguro, tendo por fim, requerido:

- a revisão do contrato de mútuo, com a verificação dos juros pré-fixados desde a primeira prestação, fixando o limite de juros simples efetivos

aplicados nas relações negociais pactuadas no financiamento em 10% ao ano;

- fixada a taxa de juros, que seja expurgada a Capitalização de juros praticados durante toda a relação contratual, e que antes do reajustamento do saldo devedor seja amortizado o valor pago pelas prestações durante o ano corrente;
- fixada a taxa de juros na forma acima, seja aplicado o reajuste do PES/CP e que seja cumprido o PCR, não ultrapassando as prestações dos 30% legais permitido;
- substituição da aplicação da TR pelo INPC com incidência de juros simples em todo o período contratual; e
- revisão do saldo devedor e das prestações de todo o período contratual com a supressão de todos os índices de correção não reconhecido pelo Governo Federal e reajustado de acordo com o INPC.

Vem o Réu (Banco Bradesco S/A) em sua contestação de fls. 52/89, esclarecer que as alegações da Autora são infundadas. Basta a breve análise da planilha de cálculo anexada, que nota-se a forma de reajuste através do PES/CP. Frisa, que o contrato celebrado entre as partes, independentemente da forma de reajuste pactuada, é válido e não possui nenhum tipo de vício que possa ensejar a

nulidade pretendida na petição inicial, devendo indicar a Autora indicar de forma genérica quais os vícios que supostamente estariam contidos no citado contrato. 
